Application Forms for admission to Nursery are available 'online'. Parents and Guardians are required to fill the form online. The link to fill the form will be available from 4th of August, 2022 on the School website: www.nirmalaconventschoolsiliguri.com. Fill in the required details and submit the same online. Please note that any application form, not duly filled in or the forms that are incomplete will be automatically rejected by the software. This application can be submitted online on any day between 4th August and 31st August, 2022. **You are requested to take two copies of the entire document for future use and reference.** Your form will have a unique Registration Number which will be used for all future correspondence and reference.

Kindly go through the instructions mentioned below before filling up the form.

AGE CRITERIA

Girls born between **01.10.2018** and **01.10.2019** are eligible for admission to **NURSERY**.

REQUIREMENTS

DOCUMENTS TO BE KEPT READY BEFORE FILLING FORM

1. Student Photo (size below 500 KB)
2. Birth Certificate Scan Copy (size less than 5 MB).
3. Residential proof Scan Copy (size less than 5 MB).
4. Recent Photograph of Parents with daughter (size less than 5 MB)

Any error in filling up the admission form will be liable to be rejected.

ADMISSION FORM FEE

A sum of Rs.800/- (Rs. Eight Hundred only) will have to be paid online as the form fee while filling up the form. This money will not be refunded for any reason whatsoever. Once the payment is successful, kindly wait for the page to redirect back to the application which will mark the status of payment on the application form as paid. The application form copy must be submitted at the school counter in the given dates.

1st September and 2nd September 2022 between 9:30 am and 12:30 pm at the School Office.

Steps to follow after applying online

The following documents are to be presented for verification at the school counter.

- 1) Carry one copy of the downloaded Application-Form, downloaded from the site with one copy of a recent stamp-size colour photograph of the applicant and a postcard size family photograph (only father, mother and child).
- 2) Attested Birth Certificate, both the Original (Municipality Registration Certificate. Registration within one month after birth is valid) and a Photocopy. (The Original Birth Certificate can be collected back soon after the verification)
Catholic children will produce the baptism certificate along with the letter of the Parish Priest, besides the above.
- 3) Residential Address proof & Aadhar Card of the Parents
- 4) Medical Fitness Certificate from a Registered Practitioner (original)

- **Anyone failing to do so their application will be automatically rejected**

SELECTION

- **The date of interaction of the parents and the child will be intimated on the same day of the submission of the application form.**
- The candidates will be selected based on the interaction with the parents and the candidate by the Principal or one delegated by her.
- Recommendations will **DEBAR** the admission to the school.
- Selection for Interaction is not a guarantee for admission.
